

## How to create and use the CPD Record

1) Log in to the APPN site, and click on the 'Competency' tab




- 2) Click on the 'Start Using CPD Record' button
- 3) Under CPD Type, select 'GP' from the drop down list, and the CPD start date will be prefilled in with the start date of the current triennium period.
- 4) Click on 'Create CDP Record' button


- 5) All modules are listed under the 'In Progress', 'Available Modules' or 'Completed Modules 'depending on the status of that module
- 6) Select your CPD organisation by clicking on the 'CPD Points' drop down menu. Next to 'RACGP #' or 'ACRRM #', click on the '(not set)' link and a box will appear to enter in your membership number, then click 'Apply'.




- 7) Click on the plus symbol to expand a module Note: Clicking on the minus symbol will collapse the module
- 8) Select your training stream (device you use in your workplace) from the drop down menu. Click on the 'Apply' button.



9) Clicking on the task underline in blue will direct you to the document/presentation. Ticking the box will mark the task as completed and the date will appear in the 'Date Completed' column.


Note: If you need to refer back to the document/presentation you can still click on the link





- 10) Once you have completed a task in the module, the module will move to the 'In Progress' section.
- 11) Once you have read the document/watched the presentation, click on the enter doorway symbol' to take the corresponding competency test

Note: You can do read the documents and do the corresponding competency tests in any order



- 12) Once you have completed a competency test, you will receive a certificate for that competency. You can download the certificate at a later date by clicking on the 'download certificate' icon.
- 13) To complete the module, all tasks marked with an asterisk symbol must be completed




14) Once all mandatory tasks has been completed, an <sup>1</sup> 'enter doorway symbol' will appear next to the Module Evaluation. Click on it to complete the evaluation.

Note: The evaluation must be completed before APPN can submit point to RACGP/ACRRM.



15) The module will then move to the 'Completed Modules' section and the 'Print Certificate with CPD' will be activated so you can download your certificate with CPD.
